What's in these terms?

These terms tell you the rules for using our website www.minipip.co.uk (including Minipip Pro+ or Educational Pro+) ("**site**").

Who we are and how to contact us

www.minipip.co.uk is a site operated by Minipip Limited ("**We**"). We are registered in England and Wales under company number 12377177 and have our registered office at 10 Thornbury Walk, Hull HU7 3JY. We are a limited company.

By using our site, you accept these terms.

By using our site, you confirm that you accept these terms of use and that you agree to comply with them.

Which country's laws apply to any disputes?
